Dear Sir/Madam, Dear Ms. Vuksa,

I am writing to address your letter dated June 23, 2023, regarding an outstanding balance of \$125 CAD and the invoice I received for the installation of smoke detectors in my apartment, unit 103. Please be advised after receiving your initial letter, dated May 5, 2023 (see the attachment #1), regarding smoke detectors replacements, I exercised the option 2 provided in your letter, as I purchased the smoke detectors myself in 2022 (one year before of your smoke detectors replacement company by Altron contractor). So, I replaced the original smoke detectors by identical ones BRK9120BA after careful consideration and consultation with professionals in the field. So, on May 19, 2023, I provided the contractor with a copy of the receipt for the smoke detectors I purchased (he refused to identify himself) because I was incredibly busy with my mother-in-law's funeral. At the time, I didn't back up or fax my receipts because I believed the contractor would pass them on to your office (as the silence from your end had lasted for more than five weeks), and I assumed everything was good.

Therefore, I was surprised to receive the invoice for the installation with your letter, dated June 23, 2023 (the attachment #2; it rec'd on June 28, 2023), as the smoke detectors were not installed by the contracted company but rather by myself, in adherence to the choices outlined in your letter. I would like to reiterate that I have not signed any documentation indicating that the work was completed by the contractors.

As a former police and intel officer, I want to highlight the significance of adhering to the law by every member of our society. It's worth discussing a few crucial aspects of fire safety regulations to demonstrate their importance. So, understanding and following fire safety regulations is not just a mandate, but a critical responsibility for each of us. These regulations exist not only for our personal protection but also for the overall well-being of our communities, particularly our small Terra Losa Community. At this point, I am extremely perplexed by your violations of ethical conduct, manipulations, and accusations regarding our alleged failure of the annual inspection, as indicated in your initial letter dated May 5, 2023. Before accusing us of failing the annual inspection, you must provide the fire safety non-compliance inspection report with all grounds (with relevant fire safety code of articles & clauses, etc.) as outlined by the Fire

Safety Regulations. I asked my neighbours about these letters; so, two of my neighbours got the same letter with the same accusation of failing annual inspection (just address stickers were different).

In addition, I was a company owner, and I have pursued a Canadian MBA and obtained two different engineering degrees from Europe. Furthermore, I hold a BCom in Accounting with Distinction (GPA 3.9 out of 4.0) from MacEwan University (Edmonton, AB), and a BBA in Finance with Honours (GPA 4.0 out of 4.0) from the Northern Alberta Institute of Technology (Edmonton, AB). With my extensive business experience and educational background, I received numerous invoices from contractors, and I have never encountered invoices with such significant violations of accounting standards and regulations as the one I have received from your company. The absence of owners' signatures or confirmation regarding the completion of the work raises concerns about the weaknesses in your internal controls of financial processes, particularly in billing and invoicing. These concerns are further compounded by the fact that fire safety regulations require the provision of a verification report demonstrating compliance with all fitness requirements, including adherence to the Canadian Electrical Code, National Building Code of Canada, licenses, and other relevant regulations.

Furthermore, I would like to bring to your attention that the invoice provided lacks the necessary information regarding the "Other" means specified. The invoice mentions "Total Other: 125.00," but it does not clarify what this "Other" category entails. This lack of transparency raises further concerns about your competency and ability to accurately document and communicate the charges associated with the installation. It is essential to provide a detailed breakdown of all charges, including labor, materials, and any other associated costs, to ensure transparency and understanding of the invoice (there are the fire contractor's regulations for cost estimation of labour, materials, and other associated cost based on National Building Code of Canada). The price of smoke detectors of 62.50 Cad (it can obtain online or from the retail store at least 2-3 times cheaper) with the 5 minutes of installation job of 60 Cad (the smoke detectors replacement job is similar as a home bulb replacement) also bring into consideration many concerns (not only ethical ones) about the contractor's bidding process with picking the qualified contractor at the reasonable price.

Given the circumstances, I kindly request you cancel the invoice (I attached receipts as Altron didn't pass it to you) and remove the charges related to the smoke detectors installation from my account and improve your internal control in the billing processes Also, I would like to get your clear clarifications regarding the accusations in letter, dated May 5, 2023) regarding failing the annual inspection(s). So, please provide or provide the annual verification report of failure(s) with all relevant codes, articles, clauses or provide your official written apologies for it.
